In addition, I acknowledge that I am 18 years or older and agree to be bound by and to comply with the following terms and conditions:

1. I will provide proper and sufficient food, water, shelter and kind treatment for the animal at all times.
2. I will provide proof of rabies vaccination to Temple Animal Services no later than 2/13/24. This vaccination can be from the veterinarian of my choice.
3. I will not abandon the animal.
4. I will not allow the animal to be used for purposes of vivisection or experimentation.
5. I will not permit the animal to run at large or to become a public nuisance, will keep means of identification on the animal at all times, and will immediately retrieve the animal from any public or private shelter when notified that the animal is being held at any such location. In the event the animal becomes lost, I will make every reasonable effort and attempt to relocate and claim the animal.

This contract may be specifically enforceable by the City of Temple Animal Services through judicial proceedings, including the right of the City of Temple to recover the animal due to any breach of any terms of this contract. I hereby agree that in the event I breach this contract and the City of Temple files suit to enforce this contract or to defend any claim under this contract, that I will pay any court costs and attorneys' fees incurred by the City of Temple Animal Services in connection herewith.
